

#### MENTAL HEALTH STAFF ORIENTATION

# I. GENERAL

This Alabama Department of Corrections (ADOC) Administrative Regulation (AR) establishes the policies, procedures, and responsibilities for orienting new Vendor staff to working in a correctional setting.

# II. POLICY

It is the policy of the ADOC to ensure that the Vendor provides orientation and training to all new Vendor staff on correctional facility security, all applicable ADOC ARs, unique aspects of correctional mental health services, and individual job descriptions.

# III. DEFINITION(S) AND ACRONYM(S)

There are no definitions prescribed in this AR.

#### IV. RESPONSIBILITIES

- A. The ADOC Director of Mental Health Services is responsible for ensuring oversight of the development of this AR.
- B. The Warden (or designee) at each facility is responsible for ensuring that all ADOC staff at that facility receive training on the implementation of this AR.
- C. The Vendor Mental Health Program Director is responsible for ensuring all new Vendor staff receives training on the implementation of this AR.

- D. The Vendor Health Services Administrator at each facility is responsible for ensuring all Vendor medical staff at that facility receiving training on the implementation of this AR.
- E. The Vendor Mental Health Site Administrator at each facility is responsible for ensuring that all Vendor mental health staff at that facility receiving training on the implementation of this AR.

#### V. PROCEDURES

- A. The Warden (or designee) at each facility will ensure that all newly hired Vendor staff at that facility receive an initial orientation before assuming job duties that covers at least the following:
  - 1. Organizational structure of that facility.
  - 2. Essential security information.
  - 3. Tour of that facility.
  - 4. Security of identification badges and assigned keys (if applicable) in accordance with AR 201, *Issue and Control of Employee Identification Cards*.
  - 5. Staff/inmate relationships in accordance with AR 318, *Staff/Inmate Relationships*.
  - 6. Inmate sexual abuse and harassment in accordance with AR 454, *Inmate Sexual Abuse and Harassment (Prison Rape Elimination Act [PREA])*.
- B. The Vendor Health Services Administrator and the Vendor Mental Health Site Administrator at each facility will both ensure that all newly hired Vendor staff at that facility receive an initial orientation within thirty (30) calendar days from the first date of employment that covers at least the following:
  - 1. Individual job descriptions.
  - 2. Organizational structure of medical and mental health services at that facility.
  - 3. Confidentiality in mental health services in accordance with AR 604, *Confidentiality in Mental Health Services*.
  - 4. Comprehensive Mental Health Training in accordance with AR 608, *Staff Training in Mental Health*.

- C. The Vendor Health Services Administrator and the Vendor Mental Health Site Administrator at each facility will both ensure that all Vendor staff at that facility complete ADOC Form MH-005, *Mental Health New Staff Orientation*, upon completing staff orientation and training that will be maintained in that individual's employee file.
- D. The Vendor Health Services Administrator and the Vendor Mental Health Site Administrator at each facility will file the completed ADOC Form MH-005, *Mental Health New Staff Orientation,* in the staff's employee file.
- E. The Vendor Health Services Administrator and the Vendor Mental Health Site Administrator at each facility will ensure that all Vendor staff at that facility attend ADOC New Support Training in accordance with AR 219, *Training*.

# VI. <u>DISPOSITION</u>

Any forms used will be disposed of and retained according to the Departmental Records Disposition Authority (RDA).


# VIII. SUPERSEDES
