- \* Statistical data assessing confiscated contraband, including cell phones, electronic devices, weapons, and controlled substances.
- \* Statistical data assessing incidents of sexual abuse and sexual victimization, including dates, facilities, nature of incident, and numbers of inmates / staff involved.
- \* Statistical data assessing number, manner, and cause of inmate deaths.
